- 5. Arbor Day Festivities

 - a. Tree Planting Schedule VanBogaert said we are planning on planting 60 trees this fiscal year after May 1, in the fall and next March.

 would like to partake.
 - c. Tree Removals There are quite a few tree and stump removals that need to occur around town. Some will be completed this fiscal year.
